The ICFAI Society, Hyderabad (the Society) has procured 30.43 acres of land and developed state-of—the-art campus with all modern facilities for exclusive use by the University. The Society has arranged the funds partly from its internal sources and partly through bank loan. It was agreed that the University repays the bank loan along with interest and also the margin money provided by the Society as and when the cash flows of the University permit.

Once the University clears the liability on account of bank loan, interest and other funds provided by the Society, the title and ownership of the land and buildings will be transferred to the University. The Society has also provided funds for establishing the Endowment Fund with the State Government and for meeting operational deficits.

The amount provided by the Society against the above funding is Rs.77.54 crores as on March 31, 2024. During the year 2024-25, the Society has provided funds to the tune of Rs.8.27 crores towards Capital Work-in-progress and Rs.7.98 crores for other fixed assets and meeting operational expenses. Thus, the total amount provided by the Society is Rs.93.79 crores as on March 31, 2025.

Further, the University has been utilizing the Overdraft facility for meeting operational expenses and the balance outstanding as on March 31, 2025 is Rs.4.46 crores. Efforts will be made to increase the revenues of the University and control the expenditure judiciously to reduce the deficit in the current year and the outstanding amount to the ICFAI Society will be repaid in due course depending upon the cash flows.
